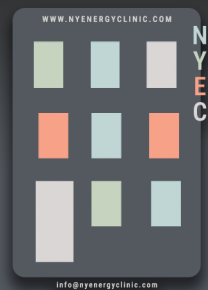

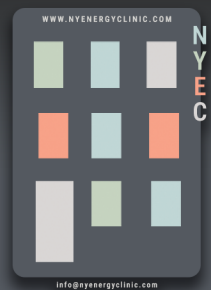

7. Amendments to this privacy statement

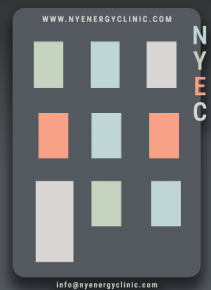
